

End Point Assessment (EPA) centre registration form



This form should be completed by organisations that wish to register as an EPA centre for the Accounting Apprenticeships and who are not already AAT approved training providers or assessment venues. Organisations should register at least two months before their first planned EPA.

The registration process

Complete all sections of the form, providing us with details of your organisation and apprenticeship offer.

Once we receive your completed registration form we'll review it, requesting any additional information.

Providing our requirements for approval are met, we'll complete your registration and confirm this in writing.

Operating as a registered EPA centre

Once you're operating as an EPA centre, we'll monitor your compliance with all relevant requirements published by AAT for the delivery of EPAs, including the conduct of CBAs.

AAT conducts unannounced Assessment Quality Assurance Visits (AQAVs) from time to time. The purpose of these visits is to ensure that CBAs are conducted in accordance with AAT policies and procedures, and as an opportunity to offer support. The visits may be conducted at random, or in response to specific incidents or feedback. The AAT representative that conducts the visit will provide a letter detailing the parameters of the AQAV. EPA centres are required to co-operate with those carrying out such visits. If the findings of a visit are deemed unsatisfactory, a follow up visit may be conducted. AAT reserves the right to recover the cost of follow up visits from the EPA centre.

Suspected malpractice or maladministration, i.e. conduct or practices that may jeopardise the validity and integrity of the assessment process, must be immediately reported to AAT. Any suspected cases will be investigated to determine whether or not any irregularities have occurred. Investigations will be conducted in a fair and reasonable manner. During the investigation it may be necessary for AAT to temporarily suspend the EPA centre's responsibilities. If the investigation concludes that irregularities have taken place, the EPA centre may be subject to sanctions.
